

Ocean carriers are rushing to buy new superpost-panamax vessels in a way that suggests that balancing future supply and demand is not the main driver behind these decisions. Cl assesses what the other likely motivators are and reports on the possible devastating long-term consequences from this latest contracting binge.

The exit of the niche carrier The Containership Company (TCC) from the transpacific trade earlier this year has raised some doubts as to whether such operations can survive, especially in mainline trades. But Grand China Shipping is expanding in the same market and there are examples where the niche concept works well in US trades. Cf Investigates.

CI reports on the current state of the Mediterranean/east coast South America trade which over the years has played host to many different operators and carrier strategies and where supply and demand has rarely been balanced and freight rates highly.

The shipment of automotive parts and components accounts for a significant slice of box traffic for many ocean carriers while shippers/consignees are often very demanding of the services they want. Failure to deliver can have profound and very expensive repercussions for all concerned, CI

in a number of ports across the world, port-centric logistics concepts have been successfully implemented. CI looks at how such an approach may be adopted in India, where landside infrastructure has always been extremely challenging but where cargo flows are rising rapidly and the demand for valueadded logistics services is growing.
