There are no page charges for *IFT members*; for *non-IFT-members*, a charge of \$85 per printed page for the first 4 pages (\$120 for each additional page) applies to all manuscripts on original research. Color figures can be included in the print version for a fee of \$500 per figure, or online only for free. When payment is possible only from an author's personal funds, and this means of payment would impose undue financial hardship, a request for **partial or full waiver** of page charges can be made, provided this is done **prior to publication**. In this instance, a **statement certifying** that the author's employer(s) is unable to pay because of financial distress, and that the author cannot personally pay because this would impose an undue financial burden, signed by both the author and the employer, should be sent—**prior to publication**—to: JFS Managing Editor, Institute of Food Technologists, 525 W.
